



Tuition Contract

2019 Monthly fees for Transitional Kindergarten through 5th Grade

EH provides transportation and care for children whose homeschool is Nimitz, Stockmeir, or West Valley Elementary. EH follows the Cupertino Union School District calendar. Children from other schools or school districts are welcome, but transportation to EH will need to be provided and/or arranged by parents.

After School Care Tuition:

Price includes a ride from school to EH and early dismissal days. Tuition fees are billed monthly based on a calendar year. EH closures are averaged into the monthly fees.

Inservice Days:

Inservice days are days when the elementary schools are closed, but EH is open. These days are subject to an additional fee as listed below.

Enrolled EH child	\$60 per day
Non-enrolled EH child	\$95 per day

Summer Camp:

Summer Camp is a full day program which runs for 9 weeks. Cost includes all field trips, t-shirt and project materials.

Upon enrollment there is a non-refundable deposit of \$300. \$150 is retained as a registration fee. \$150 will be credited towards the tuition of your child's last month at EH.

EH's regulations and guidelines

- Tuition is due on the first of every month.
- Tuition must be registered for direct payment through Tuition Express.
- The sibling discount is 10% off the older child (or children, when there are more than two).
- There are NO holiday, sick or vacation credits for any days or weeks your child may miss.
- If you would like your child to attend an extra day the rate is determined by your child's age group and schedule category. Extra days may not be granted if the program is full for the day requested.
- A written or emailed 30 day notice is required upon withdrawing from the school.
- EH will not refund tuition, including the time within the required 30 day notice period.
- A child will move to the next age group when the teachers and parents agree that the child is developmentally ready to move up, *and* when space is available. Curriculum in each classroom is fluid, changing as the needs of the children currently enrolled in that room change.
- EH understands undesirable behaviors in children arise. We do not have a black and white policy regarding these behaviors. We assess each situation on a case by case basis and will use a "shadow" after discussing all other options first. A shadow is a teacher dedicated solely to your child to help with the cessation of a particular negative behavior.

Additional fees

- Tuition received after the 4th of the month will incur a \$40 late charge. An additional \$5 per day will be added to the late fee for every day after the 4th.
- There is a yearly, nonrefundable fee of \$325 per child/\$425 per family, collected every August. This fee is separate from the registration fee. Children enrolled after September will pay a prorated fee: Oct-Jan \$225/\$325, Feb-Jul \$175/\$225.
- There is a \$10 late fee for children picked up after their scheduled end-time, and an additional \$1 per minute will accrue after 15 minutes of late pick-up.
- If your child will be absent from elementary school it is your responsibility to let us know they will not be attending EH. There is a non-notification fee of \$20 per day if we do not receive notification of absence **prior** to your child's after school pick-up time.
- Children enrolled for less than 5 days per week may request an extra day at the fee of \$50 per day. An extra day may not be granted if the program is full for the day requested.
- Non-enrolled EH children may drop-in for after school care at the rate of \$60 per day. Drop-in care may not be granted if the program is full for the day requested.
- Custom pick-up times are at the discretion of the directors and will be charged a flat rate of \$50 per ride.
- Should your child need a shadow (a teacher dedicated solely to your child to help with the cessation of a particular behavior) you will be billed an additional \$100 each day the shadow is needed.

I have carefully read and agree to pay the appropriate tuition for my child, and I will comply with all regulations and fees outlined above.
